IMPORTANT NOTE

Carefully read through this entire instruction manual thoroughly before attempting to install this part.



IMPORTANT NOTE

Cover material will stretch upon installation and once fabric is warmed up. Allow cover to lay out in the sun for 30 minutes prior to install. We recommend install in temperatures above 75°F.



WARNING

Park vehicle on flat surface, chock all four wheels and engage parking brake prior to installation.

Serious injury can occur when working on vehicles alone. When possible, work with another person to reduce risk of injury from strain or other dangers that can occur when working alone.

Installation Instructions: 2 Door Bronco Cab Cover



Step 1:

Fold both side mirrors in. Then, locate the front of the cover and drape it over the vehicle.

Note: It is helpful to position the windshield wipers away from the vehicle, in their service position.



Step 2:

Locate the 4 side straps and attach them below the door. These can be attached to the pinch weld or directly to the frame. You can also wrap the strap around the body mount bolts and attach to the body mount cup **Note: Do not overtighten straps, damage to straps, cover, and/or vehicle may occur!**

Step 3:

Locate the 4 rear straps and attach the two sides to the underside of the rear fender. Then, attach the rear two to the underside of the tailgate.



Step 4:

Lower the windshield wipers to their normal position.



Step 5:

Installation is now complete.

Product cleaning and maintenance instructions

Stainless Steel Finish – Aluminum polish may be used to polish small scratches and scuffs on the finish. Mild soap, window or glass cleaner may be used to clean the finish. Dual state powder coat finish – Mild soap, window or glass cleaner may be used to clean the finish. In order to protect the finish, you may wax your product on a regular basis with pure carnauba automotive wax. Do not use any types of soap, polish or wax that contains abrasive that could damage the finish. Textured coated finishes should be cleaned with a mild soap on a damp sponge. Do not apply polish or wax that requires to be removed by means of buffing. This type of wax is commonly used at car wash facilities. Chrome Finish – Mild soap, window or glass cleaner may be used to clean the finish. In order to protect the finish, you should wax your product on a regular basis with pure carnauba automotive wax. Do not use any types of soap, polish or wax that contains abrasive that could damage the finish.

This warranty does not cover labor of part replacement of the cab cover. SAP will, at its sole discretion, provide replacement part (s) for a defective cab cover or component, provided this is done within the warranty period. To request assistance under warranty, one must call or email using the phone number or email at the bottom of this page. This warranty does not apply (1) wear-able components; or (2) if the cab cover has been damaged, including, but not limited to: abuse, misuse, collision, modification, misapplication, improper installation, or improper service. This warranty is void if any SAP serial number has been removed or defaced; or if cab cover is used for any commercial, industrial, or rental applications. This warranty only applies to Cab Covers bought, sold, and used within the United States or Canada unless otherwise specifically agreed in writing by SAP.
