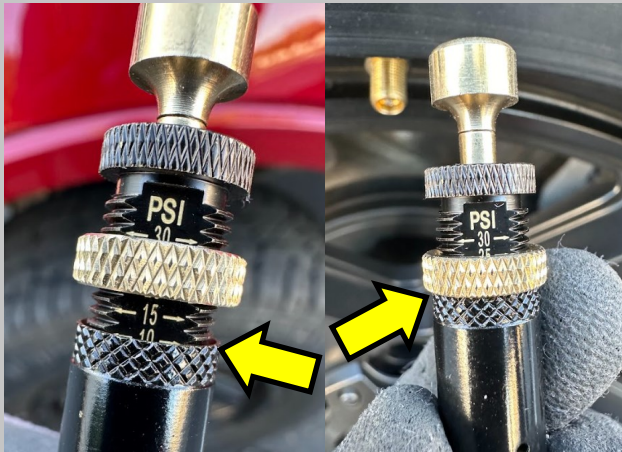

# Operating Instructions



## Step 1:

When ready to use the deflators, remove them from the carrying pouch. Unscrew the top half from the bottom half until the bottom half lines up with the arrows for your desired tire pressure. Then screw down the gold ring until it sits snugly against the bottom half. Do this for all 4 deflators

**Note: The photos on the left are set to 10 PSI.**



## Step 2:

Screw all 4 deflators onto each tire. The deflators will automatically begin deflating the tire to the set PSI.



## Step 3:

Once the tires reach the set PSI, the deflators will stop releasing air. Once done, the deflators can be removed and stored back in the pouch for future use.

**Note: to preserve the longevity of the internal spring it is recommended to set them to below 15 PSI when not in use.**

To request assistance under warranty, one must call or email using the phone number or email at the bottom of this page. This warranty does not apply (1) to finish or paint; (2) if the tire deflators have been damaged by accident, abuse, misuse, collision, modification, misapplication, improper installation, changes to the factory set parameters, or improper service; or (3) any normally wearable part. This warranty is void if any SAP serial number has been removed or defaced; or if the tire deflators are used for any commercial, industrial, or rental applications. This warranty only applies to tire deflators bought, sold, and used within the United States or Canada unless otherwise specifically agreed in writing by SAP.
