

Installation Instructions Part# 91306 4 door JK bow assembly 2007-2018

NOTE: Carefully read entire instructions thoroughly before attempting to install this part.

M6-1.0x20mm button head bolt	8
Roll bar bracket	<u>L&R</u>

Actual design may vary from photos. Install remains the same.



Step 1: Attach roll bar bracket onto the roll bar using M6-1.0x20mm button head bolts. These bolts will thread into existing threaded holes in the roll bar. Take care to no pinch any of the roll bar cover between the bracket and the roll bar. Fig 1, passenger side shown. **Step 2:** This step is easier with two people. With the bow assembly folded, attach bow assembly onto the roll bar brackets. The bow assembly has a "T" that will drop into the slot on the roll bar brackets. Then secure with M6-1.0x20mm, start each screw before tightening to ensure bracket alignment. Fig 2 shows the bow assembly bracket and "T" that will attach to the roll bar bracket. Fig 3 shows how the "T" will clip onto the roll bar bracket. Fig 4 shows the same installed on the jeep. It may be easier to slightly unfold the bow assembly and place onto the rear door surrounds.





Note: Start all bolts by hand before tightening to ensure proper alignment.




<u>Step 3:</u> Open the bow assembly half way and locate the slider block on to the top of the rear door surround. Ensure slider block can be secured to door surround if your door surrounds have the fold back feature. On vehicles without fold back feature you can upgrade your door surrounds using Smittybilt's door surround kit or Mopar door surround. Fig 5 and 6.

<u>Step 4:</u> Open bow assembly completely and latch to windshield frame.

Note: When opening bow assembly first unlatch from windshield. Open the bow assembly evenly left to right. This is easiest by pushing up and back on the bow assembly from inside the vehicle. Once the front half is unfolded, the bow assembly can be unlatched from the door surround. When using the fold back feature ensure you use the bow straps to secure the front part to the rear part. This will prevent the top from folding unexpectedly. Fig 7, shows the strap with the top folded back into the fold back position. When lowering top completely, attach plastic tether strap by looping it around the hook on the pivot bracket. Fig 8.

<u>Step 5:</u> Install soft top according to top manufactures instructions.
